Public Hearing on Local Law No.2-2024 Noise Control and Regular Monthly Meeting Minutes
May 20, 2024

The Kortright Town Board held a Public Hearing on Local Law No.2-2024 Noise Control and Regular Monthly Meeting on May 20, 2024 at 7:30pm in the Town Hall, 51702 State Highway 10, Bloomville, New York.

Present: Councilman Micheal Pietrantonio, Councilman Jeff Haynes, Councilman Nikki Pickett and Supervisor George Haynes Jr.

Absent: Councilman Chad Boest

Other Present: Highway Superintendent Bill Burdick, Code Enforcement Officer Josh Morgan and Liz Page

Supervisor Haynes, Jr. opened the Public Hearing for Local Law No.2-2024 Providing for the Control of Unreasonable Noise at 7:30pm.

Supervisor Haynes, Jr. closed the public hearing and called the Regular Monthly meeting to order at 7:31pm, on a motion made by Councilman Pietrantonio and seconded by Councilman Haynes.

The privilege of the floor was granted to the Code Enforcement Officer Josh Morgan; Josh spoke about increasing the building permit fees and presented the board with his suggested fees. Councilman Pietrantonio asked if he could charge by the inspection, especially if you have to go back due to something not passing and Josh doesn't think the Town will ever get the money if we do it that way. Josh added that the codes have changed and will be changing even more. The board will continue to think about increasing the fees.

Communications:

The paving for the DPW project is scheduled for mid June.
Supervisor Haynes, Jr. spoke with the United Post Office about the mobile unit behind the Town Hall. They wouldn't need water or sewer but electric; the offer is \$2,100.00 for the first 5 years and \$2,252.00 every year after. On a motion made by Councilman Pietrantonio and seconded by Councilman Pickett to approve if they are paying for the electric hookup.

The Town is still in need of a Dog Control Officer.
Supervisor Haynes, Jr. spoke with Jane DeWitt about the stonewall repair at some cemeteries; he also spoke to Jody Dorosky but she doesn't have anyone to help with the stones.

New Business:

Councilman Pietrantonio made a motion to approve the Local Law No.2-2024 Control of Noise, seconded by Councilman Pickett.

Supervisor Haynes, Jr. motioned to approve CWT vote as follows; Eric Ball, Mike Hynes and Ed Snow. Alternates as follow; Eric Ball, Jeff Gerhart and Will Outsen, seconded by Councilman Pickett.

On a motion made by Councilman Pietrantonio and seconded by Councilman Haynes to approve payment to Aubin Brothers on the amount of \$1,600.00 for finishing the lights at the Town Hall.

Supervisor Haynes, Jr. stated that the Delhi pool will be opening soon and we could pay \$2,500.00 if we wanted Kortright residents to use it. The Board decided not to pay the fee.

The privilege of the floor was granted to the Highway Superintendent Bill Burdick. Bill reported the medium plow truck almost done and they will be removing the stumps at the old school ground starting tomorrow for \$1,500.00.

On a motion made by Councilman Pietrantonio and seconded by Councilman Haynes to declare the following as surplus and be auctioned off on Auctions International: 1997 Athey Loader, 2003 Sterling dump truck and the 1999 4255 Massey Ferguson tractor with Alamo mower.

Councilman Pickett asked if we are going to replace the trees at the park; Board agreed not at this time.
